### NATIONAL & INTERNATIONAL FUNDED SCHOLARSHIPS FOR THE PRACTICING LAWYERS OF BALUCHISTAN

### LLM/PhD IN LAW / BAR-AT-LAW (FALL 2022)

Baluchistan Education Endowment Fund (BEEF) is an initiative of Government of Balochistan is running scholarship program since 2016-17 successfully. BEEF awarded Scholarship proportionately 93% meritorious scholarships and 7% need-based gender free Scholarships covering extremely vulnerable individuals belong to the less-privileged segments of the society and so far benefitted approximately 35000 students/scholar are covering almost all education levels. It is worth-mentioning that the tragic incident of 8th August 2016 in the Sandeman Provincial Hospital Quetta took away lives of 56 Layers of Balochistan which created a huge gap. Keeping this in view. Government of Balochistan took initiatives in order to finance the educational expenses of children of the martyred lawyers and fill the gap created therein. Therefore Education funds amounting to Rs:250 Million (for each Program) were created and provided to this organization to run this program effectively. Therefore. BEEF invites applications from the Practicing Lawyers of Balochistan who intend to pursue their Law studies from the top ranked Educational Institutions / Universities (within country-out of Balochistan) under National/Inland Funded Scholarships (IPS) and UK based lawyers studies offering Institutions/Universities under International/Forgin Funded Scholarships (IPS).

#### SCHOLARSHIP CATEGORIES

International / Foreign Funded Scholarships (IPS) covering UK based top ranked law students offering Institutions / Universities only.

National/Inland Funded Scholarships (IPS) covering within country-out of Balochistan based top ranked law students offering Institutions /HEC recognized Universities only.

#### ELIGIBILITY CRITERIA

##### General Criteria:

1. Aspiring Lawyers must have taken admission in any one year study course of LLM or PhD in Law or Bar at Law are being offered by country-wide out of Balochistan based top-ranking national institutions or UK based International institutions.
2. Only the admission taken for session Full -2022 would be eligible.
3. Applicants must possess Balochistan Locale/ Domicile.
4. Applicants must have qualified LAW-GAT with minimum score as requested by HEC.
5. Applicants must have the valid Balochistan Bar Council registration/Licence with at least 2 years' practicing experience.
6. Applicants must have received unconditional offer letter from the institutions/ Universities offering Law studies;
7. Ensure Alumni Networking.
8. Applicant must submit an original signed copy of Bond/affidavit on stamp paper worth Rs:50/- for confirming that after successful completion of study course and return he/she will be committed to serve the Balochistan province for minimum two years.
9. Applicants must submit an original signed Personal Security / Surety Bond on stamp paper with Rs:50/- from an Gazetted officer of Federal / Provincial Government for taking the responsibility and held accountable.

## SPECIFIC CRITERIA FOR INTERNATIONAL SCHOLARSHIP

1. Applicant must Possess valid passport.
2. Applicant must have scored at least 6.5 bands in IELTS.

### COVERING COSTS

1. Tuition Fee
2. Living Cost
3. Air Ticket around Trip via most direct route

### DEADLINE:

The deadline for submission of scholarship application Form (SAF) 2021-22 for both FFS/IFS categories is **30<sup>TH</sup> APRIL 2022**.

## SPECIFIC CRITERIA FOR NATIONAL SCHOLARSHIP

1. Applicant must have obtained 2<sup>nd</sup> division from HEC recognized Institute

## CHECK-LIST OF PRE-REQUISITE DOCUMENTS

1. Duly filled verified/endorsed scholarship application form (SAF) 2021-22
2. Attested copy of Local/Domicile certificate (Applicant/Father)
3. Attested copy of valid balochistan Bar Council (registration)/Licenses
4. Required at least 2 years practicing experience of lawyers
5. Attest copy of CNIC of Applicant & Father /Mother /Guardian
6. Attested copy of passport (for FFS Applicant only)
7. Attested copy of result transcripts /Marks sheet of LLB.
8. Attested copy of IELTS result (For FFS applicant only)
9. Unconditional offer letter of admission in LLM /PHD in law/Bar at law(Fall 2022)
10. 4 fresh attested photograph of the applicant (3 from back & one from front)
11. Original bond/affidavit on stamp paper worth rupees 50 for conforming that after successful completion of the study course he/she will return & will be committed to serve the province for minimum 2 years.
12. Personal security/ surety bond on stamp paper worth rupees 50 from a gazetted officer of Federal/Baluchistan Domicile/ Provincial Government for taking the responsibility & held accountable to refund total amount to BEEF in case the applicant does not return back due to any reason (discontinue/left study course incomplete) or completed but not return back to serve the province as per commitment
