



**FALL 2026 SESSION**

Applications are invited from aspiring practicing lawyers of Balochistan for Fully Funded LLM Scholarships at foreign universities duly approved and notified by the Pakistan Bar Council. The scholarship covers:

1. Complete University Fee
2. Monthly Stipend covering the cost of living
3. Return Air Tickets/Visa Fee/Health Insurance

**Eligibility Criteria:**

1. Local/Domicile of Balochistan
2. Must not be older than 40 years till cut off date
3. Un-conditional Offer Letter for LLM only from foreign universities approved and recognized by Pakistan Bar Council.
4. Must have valid Balochistan Bar Council License with at-least two years practicing experience till cut-off date certified by Balochistan Bar Council on prescribed proforma of BEEF certified from the office of the Advocate General Balochistan/Chairman Balochistan Bar Council.
5. To substantiate, the practicing status, the experience certificate issued by Bar Council shall be accompanied by at-least fifty (50) order sheets obtained in the last two (2) years
6. Must have secured at-least 6.5 Bands Aggregate Valid (not expired) IELTS Score regardless of the requirement of the Institution/University. Documents such as English proficiency or any other proficiency test etc in lieu of IELTS will not be accepted.
7. HEC Attested LLB Degree and DMC. Relevant Board attested Matric and Intermediate Degree and DMC.
8. Scholars having availed scholarship previously under this program shall be ineligible for scholarship under this program again for any degree.
9. Two Separate Guarantees on Rs. 500 Stamp Paper: A Self Guarantee and a Guarantee from Gazetted Government Officer of not less than BS-17 duly attested and notarized that in case of selection, the Lawyer shall return to Balochistan immediately after conclusion of studies to serve and practice in the province for 2 (two) years. Guarantor shall be held responsible for refund or for any other legal action in case of violation of this provision.
10. In case of selection, deferment of session for the next year will not be allowed in any circumstances.
11. Any fraudulent documents or alteration in credentials will result in appropriate legal action(s).

**12. Selection Process:**

- I. Aspirants fulfilling the above criteria may apply through form available at <https://beef.org.pk/download/> complete policy has also been uploaded on the link.
- II. Only the candidates fulfilling all the criteria would be shortlisted by Scrutiny Committee for aptitude test.
- III. Eligible candidates have to secure at-least 60% marks in the aptitude test and at-least 60% marks (aggregate) in the prescribed merit formula for consideration of scholarship.
- IV. Final Selection shall be made on the basis of aptitude test score and merit formula as per approved policy.

For the Fall 2026 session, three (03) slots are available. This number may increase in the event of vacancies arising from the Fall 2025 session or subject to the availability of budget. In such a case, the next candidate on the merit list will be selected accordingly. BEEF reserves the right to decide or decrease/increase number of slots based on available finances. Interested applicants may submit application form along with all the necessary documents by 30<sup>th</sup> April, 2026. Application received after the cutoff date shall not be entertained.
